#### Bulletin 98-01E

RAC SEEKS YOUR VIEWS ON CALL SIGNS

The Call sign Working Group (CSWG), a joint Industry Canada/RAC committee, has filed its report with the Canadian Amateur Radio Advisory Board (CARAB) recommending the policies and procedures that should be used in the future administration of Amateur Radio station call signs. RAC has been asked by Industry Canada to seek the views of amateurs concerning this important report. RAC will welcome comments and responses to the CSWG Report by Canadian amateurs before making any formal proposal to Industry Canada.

RAC recognizes that there are widely varying views on how station "call-signs" should be administered. RAC believes call signs are not administered in a uniform method across the country. RAC seeks to endorse policies which ensures that the final published rules and guidelines are clear and straightforward and that there is a commitment to authorizations that are uniform, evenhanded and in-tune with the needs of the majority of Canada's amateurs.

Here is a "Summary of Recommendations" of the CSWG Report:

As a result of the extensive consultations with radio amateurs across the country and of input from Industry Canada regarding the administrative ramifications of various current policies, the Call Sign Working Group presents the following specific recommendations:

- Practice of unique call signs for each province or territory
  - Continue the current practice of allocating specific prefix blocks for each province or territory and assign new blocks if required to accommodate changing circumstances, such as the creation of Nunavut or other new divisions of territory.
- Portability of call signs from province to province
  - Require amateurs who register a change of principal residence to acquire a call sign representative of their new prefix area if it is different from their current one.
- Assignment of two letter vs. Three letter call signs
  - Allow only amateurs who have attained all four qualification certificates to apply for two letter suffix calls whether it be a new license or application for re-assignment. Assign only one such two letter suffix call to any particular individual, and do not assign such calls to repeater or strictly digital stations. Additional prefix blocks should not be made available for assignment specifically to satisfy requirements for two letter calls.
- Four letter and one letter call signs
  - The current policy of assigning four letter suffix calls only rarely on an exception basis for temporary events be continued. Single letter suffix calls should only be assigned to recognized clubs, not individuals, at this time.

- How long the assignment of the call sign of a deceased amateur should be blocked
  - Do not reassign any relinquished call for twelve month after it becomes available. In the case of a call which becomes available as a result of the death of the amateur any member of the immediate family who is qualified to hold it (i.e.: all four certificates for two letter suffix) and requests the call prior to the expiration of the twelve month period should receive it.
- Assignment of unacceptable or forbidden suffixes (Q codes)
  - Do not allow the assignment of any new call signs in the QOA to QTZ range.
- Establish a list of unacceptable suffixes and circulate it to all issuing offices so that it may be uniformly applied.
- Assignment of VE0 call signs for ships
  - Retain VE0 prefix for assignment to maritime mobile stations only.
- Personal requests for call sign changes (vanity call signs)
  - Continue the practice of allowing individuals to choose any available call sign that they are qualified for. Do not at this time open any unusual or unique prefix/suffix combinations. Study the vanity call sign gating system currently being implemented in the United States with a view to using the experience they will acquire over the next twelve months to revise this policy in the future.
- Limits to how many call signs and individual or club can hold
  - Allow individuals or clubs to hold as many call signs as they are willing to pay for, as long as only one of them is a two letter suffix call and all of them represent the prefix area of the principal residence.
- Assignment of call signs for new amateurs
  - In areas where it is feasible for IC to provide a list of available calls, allow new amateurs to select the three letter call sign of their choice. In areas where a list cannot be supplied, allow the new amateur to submit up to three choices for a three letter suffix call sign.
- Special prefixes for significant events
  - Restrict the application for temporary special regional or national prefixes to recognized amateur radio clubs or organizations, not individuals. Review and revise the existing Industry Canada eligibility document (RPC 2-8-01) and ensure it is applied uniformly across the country, with a view to reducing the number of special prefix assignments that will result.
- Special event call signs
  - Assign unique call signs to celebrate or commemorate special events only to recognized amateur radio clubs or organizations, not individuals. Applications for these calls should be subject to

the normal annual fee and remain assigned to the applicant until the next routine renewal cycle.

Permanent use of "C" block prefixes

Do not consider the permanent use of "C" block prefixes.

#### Callsign e-mail addresses for all Amateurs

Any licensed Canadian amateur radio operator can now have an e-mail address of the form "callsign@rac.ca". This means that you will no longer have to advise all your contacts of any new e-mail address if you change your Internet service provider. Canadian amateurs will not have to keep track of dozens or hundreds of e-mail addresses. Just remembering the callsign is all they will need.

RAC is able to offer this free service thanks to the volunteer help and support of Information Gateway Services (IGS) of Kanata Ontario, and in particular the work of Rene Kahle VA3RDK. Rene developed the E-mail aliasing software, and set up the server hardware (IGS also donates server space for the RAC and ARAS web sites that contain much useful information for Canadian amateurs).

If you wish to obtain a callsign e-mail address, simply send message to "alias@rac.ca" "callsign=realaddress" in the body of the message. For example, if my callsign were VA4KP and my real (current) e-mail address were "ham@qsy.ca", I would send a message to "alias@rac.ca" with the following in the body of the message: "VA4KP = ham@qsy.ca" Any subsequent mail addressed to "VA4KP@rac.ca" would be redirected by the IGS server to "ham@qsy.ca". Of course it goes without saying that such mail would NOT go anywhere near RAC headquarters nor be seen by RAC officials. And of course any mail addressed directly to "ham@qsy.ca" will also be delivered as in the past without passing through the IGS server. To obtain more details, send a message to "alias@rac.ca" with the word "help" on a single line in the body of the message.

The e-mail aliasing service is currently set up on a trial basis. If it works well and amateurs find it useful, it will remain available for all who wish to use it.

#### Bulletin 98-05E

#### OPERATING REQUIREMENTS IN THE USA

RAC has been advised that Canadian amateurs visiting in the United States have been heard operating on SSB in the 14.120 to 14.150 MHz. portion of the 20 metre band. All amateurs are reminded that while in the USA, foreign amateurs (including Canadians) must observe U.S. regulations, including sub-bands. U.S. amateurs are not authorized to operate phone below 14.150 MHz. Canadian amateurs who can operate 20 metres in Canada (that is, holders of Basic plus 12WPM Certificates) may operate phone between 14.150 and 14.350 MHz. while in the USA.



### SUPPLEMENTARY BULLETIN - OPERATING IN THE USA

Further to RAC Bulletin 98-05E, RAC has now been advised that Canadian amateurs visiting the south-east United States have been heard operating portable and mobile on 75 metres SSB between 3725 and 3750 kHz. Amateurs intending to operate in the USA are again reminded that while in the USA, foreign amateurs (including Canadians) must comply with U.S. regulations, including sub-bands. U.S. amateurs are not permitted to operate phone below 3750 kHz.

# MDECG is on the verge of BANKRUPTCY! by Terry, VE4TR

With great reluctance, we regret to inform all USERS, that the MDECG is on the verge of BANKRUPTCY! With the decline of MEMBERSHIPS over the last few years, it doesn't take long for the funds to disappear.



With the mass system failures we have experienced in 1997, we are in a financial glut. With only a handful of memberships in, it doesn't come close to covering the normal expenses, dues, insurance, etc.., without having any failures.

The majority of the users of the Network are in Winnipeg and we only have moderate support from there with far greater support coming from outside Winnipeg.

We understand that there are other groups also asking for membership but they all stand alone and do not support each other financially.

With the oncoming year and expenses that far surpass our bank balance, I fear this is the last year to the network as we know it.. We have depleted the account and will only be able to cover License and Corporation fees. And unable to cover insurance costs, thus forcing us to Close the system down forever.

This network was originally developed in 1987 by myself, Terry Ryshak VE4TR, Murray Johnstone VE4TV, Mike Sanders VE4MS, Jim Townsend VE4CY, and kind support from Bill Bowman VE4UB, for which he allowed his VE4 Call sign database to be used for publishing the Call Book, and getting the network underway.. With his kind support in the Groups infancy and expertise in the mode, we had expanded rapidly, and I would personally like to thank him for all his help in the past! In 1993, the group lost the rights to publish the Call book, this hurt the group immensely for funding, as there was little financial support from the User base, and slowed the progress down immensely. In 1995, we held a Raffle for a fund-raiser for the Group, with sparse support for the endeavor, but we showed a minimal profit for it, we were also able to procure a 50/50 grant from the government, this allowed us to upgrade the back-bone to run at 9600Bd..

These past few years we experience some system failures due to USER abuse, and this caused the group further losses. And most recent a complete System loss in Minnedosa area, due to an accident from negligence on the site owners' property. Thus leaving us unable to even cover the costs for the Insurance deductible! With the maintenance of this equipment and losses from abuse, we are now ready to declare bankruptcy. I am sorry for being the bearer of this sad news.

This is a list of Members of the MDECG Group, who have paid their 1998 membership of 20 dollars. #### Reciprocal Operating Agreements and Arrangements

Canada has negotiated a number of reciprocal operating agreements that allow Canadian radio amateurs to operate their stations while temporarily visiting other countries, providing they obtain the necessary authority. Canadians who wish to operate radio apparatus in countries that participate in the CEPT Recommendation T/R 61-01 or recognize the International Amateur Radio Permit (IARP) can obtain permits from the Radio Amateurs of Canada, Inc. prior to leaving for those countries. In the case of other countries with which Canada has reciprocal arrangements, Canadian amateurs are advised to contact each administration well in advance of departure in order to obtain the necessary permit or license. There is one exception, and that is with the United States of America. Canadian amateurs do not require any

special permission to operate their stations in the United States.

#### CEPT Permit (Recommendation T/R 61-01)

Canada participates in the CEPT Recommendation T/R 61-01. (CEPT is an acronym for Confrence europenne des administrations des postes et tlcommunications, translated as the European Conference of Postal and Telecommunications Administrations.) The CEPT countries that participate in this Recommendation are as follows:

Austria, Belgium, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Hungary, Iceland, Ireland, Italy, Latvia, Liechtenstein, Lithuania, Luxembourg, Monaco\*\*, Netherlands, Norway, Portugal, Romania, Slovak Republic, Spain\*, Sweden, Switzerland, Turkey and United Kingdom.

Note: At present, additional bilateral agreements are necessary with Greece with regard to T/R 61-01.

- \* Currently, the Recommendation is only implemented for other CEPT countries.
- \*\* Location of station to be provided to the administration of Monaco.

Non-CEPT Countries that participate in this Recommendation are as follows: Canada, Israel, New Zealand, Peru and South Africa.

#### International Amateur Radio Permit (IARP)

Canada is a signatory to the Inter-American Convention of the International Amateur Radio Permit (IARP). Countries that participate in this program are as follows:

Brazil, Canada, Peru, United States of America, Uruguay and Venezuela

- General Operating Conditions and Privileges
- { Classes of Permits The CEPT permit and the IARP are similar. These permits are issued in two classes, Class 1 and Class 2. Class 1 permits are issued to those who hold an Amateur Radio Operator Certificate with Basic and Morse Code (12 w.p.m.)
- { Qualifications, while Class 2 permits are issued to those amateurs who hold only the Basic Qualification. The Advanced and Morse Code (5 w.p.m.) Qualifications are of no consequence to determine the class of the CEPT or IARP permit.
- { Privileges Granted A Canadian CEPT/IARP permit has no legal status in Canada. It is only effective for Canadian amateurs operating radio stations while temporarily in another country.

Those who hold a Class 1 permit are authorized to use all frequencies and emissions allocated in the amateur

radio service, while those who hold the Class 2 permit are limited to all the amateur allocations above 30 MHz, subject to the provisions of the visited country for the amateur radio service.

#### P Application Procedure

{ The Minister of Industry has delegated the Radio Amateurs of Canada (RAC) to issue these permits. The application for a CEPT Permit requires the name, address, call sign and class of certificate of the applicant, along with photocopies of the station license and operator certificate. RAC has set a fee of \$10 for this permit to cover the cost of administration and handling. The application for an IARP requires the name, address, call sign and class of certificate of the applicant, along with photocopies of the station licence and operator certificate, and a recent passport-size photo of the applicant. RAC has set a fee of \$25 to cover the cost of administration and handling.

Please allow at least four weeks for the issuance of the permit. Failure to submit the proper documentation may result in delays in issuing this permit.

#### Foreign Amateurs in Canada

Amateurs who are licensed by other administrations participating in the CEPT or IARP programs must apply for the appropriate permit in accordance with the provisions stipulated by their home administrations.

#### Other Reciprocal Agreements or Arrangements

Canada has concluded other agreements or arrangements with the following countries for reciprocal operating privileges. Canadians are urged to contact the responsible administrations well in advance in order to obtain the necessary documentation.

Antigua and Barbuda, Argentina, Australia, Bahamas, Barbados, Bermuda, Bolivia, Botswana, Chile, Colombia, Costa Rica, Dominica, Dominican Republic, Ecuador, Greece, Grenada, Guatemala, Haiti, Honduras, India, Indonesia, Jamaica, Japan, Malta, Mexico, Nicaragua, Norway, Panama, Papua New Guinea, Philippines, Poland, Saint Lucia, Senegal, Slovenia, Spain, Surinam, Trinidad and Tobago, United States of America\*, and Venezuela.

\* Canadian citizens holding a Canadian licence may operate in the territory of the United States without having to obtain a permit.

#### Third Party Agreements and Arrangements

Canada has concluded agreements or arrangements with the following countries to permit the transmission and reception of international communications by Canadian amateurs on behalf of third parties:

Antigua and Barbuda, Australia, Bolivia, Chile, Colombia, Costa Rica, Dominica, Dominican Republic, El Salvador, Grenada, Guatemala, Guyana, Haiti, Honduras, Israel, Jamaica, Mexico, Nicaragua, Paraguay, Peru, Saint Vincent and the Grenadines, Trinidad and Tobago, United States of America, Uruguay, and Venezuela.

# The History of Amateur Radio Revisited Condensed and submitted by Ed, VE4YU

#### Part 6

Lynn V. Salton became interested in radio in 1910 at the age of 13 while living in Moose Jaw. He began with the usual spark coil - crystal detector set and, like scores of other amateurs across the prairies, he operated without a license. He was seriously considering radio as a career by the time his family moved to Winnipeg. In 1917, while in his third year at Wesley College, he enlisted in the Royal Navy as a wireless operator. After courses in Engineering and a promotion to commissioned wireless officer, he served at Gibraltar, the West Indies and Naval Headquarters in London. Demobilized in early September, 1919, Salton returned to Winnipeg to complete his university studies and graduated as Gold Medalist in Arts in 1920.

Salton was appointed radio inspector for District 4 on June 29, 1920. At a press conference, he pointed out that licenses were required for both sending and receiving sets and that licensees must be British subjects. With appointment of a radio inspector, Winnipeg hams rushed to legalize their operations by securing a license. In 1921, Salton founded the Salton-Foster Radio Engineering Company with partner J. Ralph Foster and was elected a member of the Institute of Radio Engineers early in 1922.

Salton designed and built a 100 watt broadcaster and in February, 1922, he went on the air from his home at 1164 Grosvenor Avenue in Winnipeg, on his assigned wavelength of 420 meters with the callsign CKZC. Canadian stations were licensed to operate in the 400-450 meter band and were issued calls in the CFA(A) - CKZ(Z) series. CBC call signs were granted to Canada some years later by a concordance with the government of Chile, which then held CAA-CEZ.

When CKZC began broadcasting, there were 60 licensed amateurs in Winnipeg and 10 others elsewhere in Manitoba. A considerable number of Winnipegers had bought or built

receiving sets capable of hearing programs from the radio stations springing up across the USA. Salton went on the air on Sunday and Tuesday evenings calling "Hello, hello, this is station CKZC, Winnipeg." He began every broadcast with his favorite phonograph record "El Capitan March" .His station was reported heard at a distance of 845 miles.

The unprecedented outburst of enthusiasm for this new form of entertainment, that had swept the U.S. and eastern Canada following the commencement of broadcasting in 1919 by the Westinghouse experimental station 8XK, later KDKA, in Pittsburgh, and by the Marconi experimental station XWA, later CFCF, in Montreal, had now spread to Manitoba.
